This data privacy notice informs how we will handle your personal information in the context of communications both via our websites and away from our websites, for example in the way contracts are executed.

1. Legal grounds for personal information processing

We process ‘personal information’ (sometimes referred to as “personal data”, “personally identifiable information” or “PII”) in line with the relevant data privacy laws in the **Peoples’ Republic of China (Personal Information Protection Law of People's Republic of China: “PIPL”)** and **European Union General Data Protection Regulation (“GDPR”)** where applicable.

We will rely on one of the following processing conditions:

- **Performance of a contract:** when the processing of your personal information is necessary in order to perform our obligations under or to establish a contract with you;
- **Legal obligation:** if we are required to process your personal information in order to comply with a legal obligation, such as keeping records for tax purposes or providing information to a public body or law enforcement agency;
- **Legitimate interests:** if we may process information about you where it is in our legitimate interest in running a lawful business to do so in order to further that business, so long as it doesn’t outweigh your interests; or
- **Your consent:** if we may occasionally ask you for specific and separate permission to process some of your personal information, and we will only process your personal information in this way if you agree for us doing so.

We collect "sensitive" personal information (**Art. 28 PIPL**) only in very limited circumstances when persons voluntarily provide us this information or where such information is required or permitted to be collected by law or professional standards. Sensitive personal information refers to the personal information that is likely to result in damage to the personal dignity of any natural person or damage to his or her personal or property safety once disclosed or illegally used, including such information as biometric identification, religious belief, specific identity (nationality), medical health, financial account and whereabouts and tracks. You should not provide your or any third parties' sensitive personal information to us unless we shall separately notify you (and these third parties) and you (and these third parties) have given us your (and these third parties') explicit consent to use or process your (and these third parties') sensitive personal information for legitimate and necessary business purposes and you (and these third parties) have also consented for us to the transfer and store such sensitive personal information.

2. Visiting our websites / Cookies and similar technologies

The processing of personal information via our **website, contact forms and newsletter** is in general detailed described here at (Visiting our websites" section 3." **"GDPR" Data Privacy Notice**).

The processing of personal information as described in detail ("GDPR" Data Privacy Notice) is based on your consent prior visiting our global websites.

In general, you are not required to submit any personal information to us, but we may require you to provide certain personal information in order for you to receive additional information about our services and events. As described in detail at our (**"GDPR" Data Privacy Notice"**).

We may also ask for your permission for certain uses of your personal information, and you can agree to or decline those uses. If you opt-in for particular services or communications, such as an e-newsletter, you will be able to unsubscribe at any time by following the instructions included in each communication. If you decide to unsubscribe from a service or communication, we will try to remove your information promptly, although we may require additional information before we can process your request.

How you manage or prevent cookies is described in (section 3.5. **"GDPR" Data Privacy Notice**). If you wish to prevent cookies from tracking you as you navigate our sites, you can reset your browser to refuse all cookies or to indicate when a cookie is being sent. Note, however, that some portions of our sites may not work properly if you elect to refuse cookies.

3. Applications

You may apply to our company online or by electronic means. We process your applicant data exclusively for the purpose of the application procedure and delete it, if rejected, after completion. The processing of applicant data of Chinese nationals is based on Art. 13 (I) "Consent" and Art. 13 (II) PIPL.

4. Location-based tools

We collect and use the geographical location of your PC or mobile device. This location data is collected for the purpose of providing you with information regarding services based on your geographic location for example, to make the website available in Chinese language and provide certain services for website visitors with residence in the People's Republic of China such as the use of Baidu maps in the context of the use of our Sales and Service Locator. You can turn off the identification of your location via the **Consent Manager**, then applications like Baidu will not be available to you.

5. Baidu Maps

This website uses the Baidu Maps software provided by Baidu, Inc. for Chinese visitors in the context of the use of our **Sales and Service Locator**.

If you are a website visitor from China. Visitors from China consent to the collection, processing and use of automatically collected data by Baidu, Inc. and its user agents, **if you click on the Baidu Map**. We have no knowledge either of the exact content of the data transmitted, or the use by Baidu. We therefore do not take any liability for the personal information processing by Baidu.

6. Social Media

We are also present on the platforms of the social networks WeChat, Facebook, Twitter, LinkedIn and Xing. If you click on the respective icon on our website, you will be forwarded to our profiles there without personal data being collected by us. Any personal information that you provide via such social media applications may be collected and used by other members of that social media application and such interactions are governed by the privacy policies of the companies that provide the application. We do not have control over, or responsibility for, those companies or their use of your information.

7. General

7.1. Recipients and data transfers

RRPS and other affiliated companies house central functions of the RRPS Group and may transfer personal data for this purpose out of the Peoples Republic of China.

The following categories of recipients may receive your personal data:

- Service providers for the operation of our website and the processing of data stored or transmitted by the systems (e.g. for data processing centre services, payment processing, IT security).
- Print service providers (processors) in the context of sending e.g. information and newsletters in print form.
- Business partners (e.g. suppliers, distributors and service partners).
- Service providers or persons used to carry out our business operations (e.g. auditors, banks, payment service providers, shipping service providers, insurance companies, legal advisors, parties involved in company acquisitions or the establishment of joint ventures).
- Government agencies/authorities, insofar as this is necessary to fulfil a legal obligation.

For more information how we process personal data of our Business Partner (customer, supplier, distributors) our Data Privacy Notice for Business Partner applies.

7.2. Conditions for the transfer of personal data to third countries

In the context of your website visit and our business relationships, your personal data may be transferred or disclosed to third party companies out of Mainland China. Such processing will only take place on the basis of your consent or to fulfil our contractual and business obligations and to maintain your business relationship with us. The Rolls-Royce Group generally use the standard contractual clauses of the European Commission and, if necessary, take further measures to protect your personal data for the purpose of international personal information transfers.

7.3. Data security

We have taken extensive technical and operational precautions to protect your data from accidental or intentional manipulation, loss, destruction, or access by unauthorized persons. Our security procedures are regularly reviewed and adapted in line with technological progress.

When you use our contact form, you also provide us with personal information about yourself. In order to prevent this data from falling into the wrong hands, we use end-to-end encryption for your personal data using the TLS method for data transmission (transport layer security). This is a proven, highly secure procedure for transmitting data over the Internet, provided that it is used – as is the case here – in line with state-of-the-art practice.

7.4. Storage of your data

Your personal data will always be stored as long as it is necessary for the respective purpose (e.g. fulfilment of contract), and shall then be erased in compliance with the statutory retention periods or, after the purpose has been achieved (e.g. fulfilment of the contract by both parties), restricted (blocked) for the necessary retention period in terms of processing, and then erased.

Your rights under Clause 5.5. are to be asserted in each instance against RRPS or against such other affiliated company as be responsible under data protection legislation.

7.5. Your rights

- You have the right to request details of which personal data about you is stored (**Article 45 PIPL**)
- You may request correction or amendment (**Article 46 PIPL**), erasure (**Article 47 PIPL**) or restriction of processing (blocking) (**Article 44 PIPL**) of your stored personal data as long as this is legally permissible and possible within the framework of an existing contractual relationship. Should statutory provisions not permit erasure, your data will instead be blocked (subjected to processing restrictions) in such a way as to make it accessible only for the purpose of complying with mandatory statutory provisions.
- Should we process your data in order to conduct direct advertising, you may object to this advertising or promotion at any time with future effect (right to object to processing of personal data for marketing purposes).
- You have the right to transfer the data you have provided to us on the basis of an expression of consent or a contract (data portability), **Article 45(3) PIPL**.
- If you have given us an expression of consent to process your data, you may revoke this at any time in the same manner in which you gave it. The withdrawal of consent does not affect the lawfulness of the processing carried out on the basis of the consent up to the time of withdrawal.
