



A 10% overload capacity is available for one hour in twelve. Ratings are in accordance with ISO-8528/1, ISO-3046/1, BS 5514, and AS 2789. Average load factor: ≤ 75%. For limited running time and base load ratings, consult the factory.
- Nominal ratings at standard conditions: 25 °C and 300 meters (77 °F and 1,000 feet).
- Deration factor:
